

RESOLUTION NO. 91-229A

A RESOLUTION OF THE LODI CITY COUNCIL
TO APPROVE PETITIONING LODI MUNICIPAL COURT
TO INCREASE THE BAIL SCHEDULE FOR PARKING VIOLATION FINES

WHEREAS, the Lodi Municipal Court has the responsibility to set the amount of bail for parking violation fines; and

WHEREAS, the current bail schedule is not sufficient to cover the mandated surcharges which are distributed by the Courts; and

WHEREAS, the current bail schedule does not compensate the City for the costs of providing a parking enforcement program; and

WHEREAS, an increase in the bail schedule will reduce the City's cost for maintaining a parking enforcement program in the downtown and in the area east of Pacific Coast Producers;

NOW, THEREFORE, BE IT RESOLVED by the Lodi City Council to approve petitioning the Lodi Municipal Court to increase the bail schedule as provided in Exhibit A and to increase the penalty for late payment to \$5.00 after seven (7) days and an additional \$5.00 after thirty (30) days.


