RESOLUTION/ORDER NO. 88-155
CITY OF LODI

RESOLUTION/ORDER VACATING THE WEST FIFTEEN FEET OF RAVENWOOD WAY
LODI, CALIFORNIA

Whereas, this City Council, acting in accordance with provisions of Part III of Division 9 of the Streets and Highways Code of this state, did on the 5th day of October, 1988 pass and adopt a Resolution of Intention No. 88-140 therein declaring the intention of said City Council to vacate the west fifteen feet of Ravenwood Way, Lodi, California, County of San Joaquin, State of California, and more particularly described as follows, to wit:

The Westerly fifteen feet of Ravenwood Way as shown on "Noma Ranch" as filed for record October 30, 1984, in Volume 27, Book of Maps and Plats, Page 9, San Joaquin County Records.

Reserving and excepting from this abandonment an easement to construct, maintain, repair, replace, remove, and operate public utilities, both publicly and privately owned.

Whereas, said notice of said intended vacation was regularly given by publication and by posting, both in time, form and manner as required by law as is evidenced by affidavits on file and on record in the office of the City Clerk of the City of Lodi; and

Whereas, in accordance with the provisions stated in Resolution No. 88-140 and also contained in the posted notices of the adoption of said resolution notice was given that a public hearing would be held before the City council in the City Council Chambers, City Hall, Lodi, California, beginning at 7:30 p.m. on Wednesday, Wednesday, November 2, 1988 where and when any person interested in or objecting to said vacation could appear and be heard in relation thereto: and

Now, therefore, be it resolved that, pursuant to the findings and under the authority of Section 8323 of the Streets and Highways Code of the State of California, that there is hereby abandoned the west fifteen feet of Ravenwood Way, Lodi, California, and more particularly described as follows:

The Westerly fifteen feet of Ravenwood Way as shown on "Noma Ranch" as filed for record October 30, 1984, in Volume 27, Book of Maps and Plats, Page 9, San Joaquin County Records.

Reserving, however, and excepting from the vacation of said street, the permanent easement and the right therein to construct, maintain, repair and operate lines for public utilities, both publicly and privately owned, in, over, and across said street.

Reference is hereby made to a map or plan on file in the office of the City Clerk of the City of Lodi for the particulars as to the proposed vacation.


