

SUBJECT: Adopt Resolution Approving Abandonment of Easement  
Lots 248, 223 and 224, Lakeshore Village No. 7

RECOMMENDED ACTION: That the City Council adopt a resolution approving an order of vacation for the easement shown on the attached sketch.

BACKGROUND INFORMATION: The easement shown on the attached sketch was acquired in August 1982, and was never used. We have checked with all utilities and none are using it or have any prospective use for it. Under Sections 8333 et seq of the Streets and Highway Code, it is possible to vacate this easement without the usual notice, posting, and hearing because of the lack of use since its dedication.

We would recommend that the Council adopt the necessary resolution.
