WHEREAS, in answer to notice duly published in accordance with law and the order of this City Council, sealed bids were received and publicly opened on February 21, 2001 at 11:00 a.m. for Salas Park Playground Improvements, 2001 South Stockton Street, Hutchins Street Square, 600 West Oak Street, Century Park Playground Improvements, Century Boulevard and Church Street, described in the specifications therefore approved by the City Council on December 20, 2000; and


