

RESOLUTION NO. 2001-108

A RESOLUTION OF THE LODI CITY COUNCIL
AWARDING THE BID FOR THE PURCHASE OF 15KV
XLPE PRIMARY UNDERGROUND CABLE

WHEREAS, in answer to notice duly published in accordance with law and the order of this City Council, sealed bids were received and publicly opened on May 2, 2001, at 11:00 a.m. for the purchase of 15kV XLPE Primary Underground Cable, described in the specifications, therefore approved by the City Council on April 18, 2001; and

WHEREAS, said bids have been compared, checked, and tabulated and a report thereof filed with the City Manager as shown as follows:

WHEREAS, bidders were asked to provide a firm price and/or a variable price (which could increase or decrease, depending on the prices of copper and aluminum at the time of shipment). Since the proposals for variable pricing offered limited savings, and placed on the City the risk of price increases, staff recommends award based on the firm prices listed above.


