Proceedings were undertaken for the reorganization of certain territory as described on Exhibit "A" attached hereto and thereby made a part hereof in accordance with the provisions of Section 56000 et seq of the Government Code entitled, "District Reorganization Act of 1965."

The City Council held a hearing on January 2, 1980, at the hour of 8:00 p.m. at which time the City Council received and heard protest against the reorganization by persons within the County who do not also own property in the area of reorganization.

THE CITY COUNCIL OF THE CITY OF LODI FINDS AND DETERMINES that no majority protest was received.

SECTION I: RESOLVED BY THE CITY COUNCIL OF THE CITY OF LODI THAT IT DETERMINES:

- (a) Preliminary proceedings for the annexation of certain described territory to the City of Lodi were initiated by the filing of Resolution No. 79-138 with the Local Agency Formation Commission in the County of San Joaquin pursuant to the requirements of the District Reorganization Act.
- (b) Thereafter, appropriate proceedings were conducted by said Local Agency Formation Commission approving the proposed reorganization authorizing the City of Lodi to conduct subsequent proceedings.
- (c) Resolution No. 444 of the Local Agency Formation Commission approving the proposed reorganization and also authorized the City of Lodi to take proceedings for reorganization as the designated conducting agency pursuant to Part 5, Division I, Title 6 of the Government Code, commencing with Section 56290, et seq.

SECTION II: RESOLVED BY THE CITY COUNCIL OF THE CITY OF LODI:

(a) That each of the changes in the organization contained in the proposal for reorganization is ORDERED without an election, pursuant to Government Code Section 56439 (c). The changes of organization consist of:

- (1) Annexation of the Johnson Ranch Addition as shown on Exhibit "A" attached.
- (2) Detachment of the Johnson Ranch Addition as shown on Exhibit "A" attached from the Woodbridge Rural County Fire Protection District.

Be It Further Resolved by the City Council of the City of Lodi that Resolution No. 79-167 is hereby rescinded.
