

RESOLUTION NO. 2003-38

A RESOLUTION OF THE LODI CITY
COUNCIL AUTHORIZING THE SALE OF
SURPLUS VEHICLES AND EQUIPMENT

WHEREAS, Lodi Municipal Code §2.12.120 provides for the City Manager to authorize the sale at auction of surplus equipment having a value of less than \$2,000; however, sale of surplus property above that amount requires City Council approval; and

WHEREAS, the vehicles listed in Exhibit A attached hereto have been replaced and are no longer in use. They are currently being stored pending disposition at the Municipal Service Center; and

WHEREAS, sale at this time will benefit the City in two ways. First, the earlier the vehicles are sold, the higher the expected value will be at sale. Second, disposal of the vehicles will recover storage space needed in preparation for the purchase of power utility duct, for which Council authorized advertisement for bids on March 5, 2003; and

WHEREAS, sale at auction is the preferred method of disposal since the buying audience at auction is far larger than could be expected at a local sale. In addition, auction companies take care of the paperwork and the collection of funds on behalf of the City.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council hereby authorizes the sale of surplus vehicles and equipment as listed in Exhibit A attached hereto.
