

RESOLUTION NO. 97-78

A RESOLUTION OF THE LODI CITY COUNCIL AWARDING THE CONTRACT FOR FAIRMONT AVENUE STREET IMPROVEMENTS (KETTLEMAN LANE TO VINE STREET) AND LOCKEFORD STREET STREET IMPROVEMENTS (500 FEET WEST OF HAM LANE TO HAM LANE, AND CALIFORNIA STREET TO PLEASANT AVENUE, AND APPROPRIATE FUNDS TO COVER THE PROJECT

WHEREAS, in answer to notice duly published in accordance with law and the order of this City Council sealed bids were received and publicly opened on June 4, 1997 at 11:00 a.m., for the Fairmont Avenue Street Improvements (Kettleman Lane to Vine Street) and Lockeford Street Street Improvements (500 feet west of Ham Lane to Ham Lane, and California Street to Pleasant Avenue; and

WHEREAS, said bids have been compared, checked, and tabulated and a report thereof filed with the City Manager as follows:

WHEREAS, the City Manager recommends award of the bid for Fairmont Avenue Street Improvements (Kettleman Lane to Vine Street) and Lockeford Street Street Improvements (500 feet west of Ham Lane to Ham Lane, and California Street to Pleasant Avenue, be made to the low bidder, Granite Construction Co. of Stockton, CA; and

NOW, THEREFORE, BE IT RESOLVED by the Lodi City Council that the award of the bid for Fairmont Avenue Street Improvements (Kettleman Lane to Vine Street) and Lockeford Street Street Improvements (500 feet west of Ham Lane to Ham Lane, and California Street to Pleasant Avenue, be and the same is hereby awarded to Granite Construction Co. of Stockton, CA, the low bidder, in the amount of \$256,378.70; and

BE IT FURTHER RESOLVED, that funds be appropriated to cover this project as follows:

Street Fund (TDA)	\$218,500.00
Water Utility Fund (18.1)	\$ 35,000.00
State-Local Transportation Partnership Program Funds	\$ 28,500.00

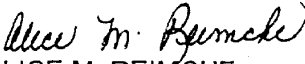
