

RESOLUTION NO. 97-79

A RESOLUTION OF THE LODI CITY COUNCIL AWARDING THE CONTRACT FOR CENTURY BOULEVARD STREET OVERLAY (HAM LANE TO CHURCH STREET) AND TURNER ROAD STREET OVERLAY (BECKMAN ROAD TO EAST END OF TURNER ROAD, AND APPROPRIATE FUNDS TO COVER THE PROJECT

WHEREAS, in answer to notice duly published in accordance with law and the order of this City Council sealed bids were received and publicly opened on June 4, 1997 at 11:00 a.m., for Century Boulevard Street Overlay (Ham Lane to Church Street) and Turner Road Street Overlay (Beckman Road to East End of Turner Road); and

WHEREAS, said bids have been compared, checked, and tabulated and a report thereof filed with the City Manager as follows:

WHEREAS, the City Manager recommends award of the bid for Century Boulevard Street Overlay (Ham Lane to Church Street) and Turner Road Street Overlay (Beckman Road to East End of Turner Road), be made to the low bidder, Teichert Construction Co. of Stockton, CA; and

NOW, THEREFORE, BE IT RESOLVED by the Lodi City Council that the award of the bid for Century Boulevard Street Overlay (Ham Lane to Church Street) and Turner Road Street Overlay (Beckman Road to East End of Turner Road), be and the same is hereby awarded to Teichert Construction Co. of Stockton, CA, the low bidder, in the amount of \$256,545.62; and

BE IT FURTHER RESOLVED, that funds be appropriated to cover this project as follows:

Street Fund (TDA)	\$249,000.00
State-Local Transportation Partnership Program Funds	\$ 33,000.00


