

RESOLUTION NO. 3650

WITHDRAWING CERTAIN PROPERTY ANNEXED TO THE  
CITY OF LODI FROM THE WOODBRIDGE RURAL COUNTY  
FIRE PROTECTION DISTRICT.

WHEREAS, the City Council did by Resolution No. 3629 effective May 24, 1972, approve the annexation of that certain **real** property, contiguous to the City of Lodi designated as "Towne Addition"; and,

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary of State on May 31, 1972, referring to said Resolution No. 3629, and the annexation of the **real** property described therein; and,

WHEREAS, the affidavit of the City Clerk of the City of Lodi certifying to the annexation of said "Towne Addition" in accordance with law **was** filed with the County Recorder of San Joaquin County on June 8, 1972; and,

WHEREAS, it is the desire of this City Council that that portion of said property designated as "Towne Addition" which lies within the Woodbridge Rural County Fire Protection District be **withdrawn** from said District; **now**, therefore,

BE IT RESOLVED BY the City Council of the City of Lodi **as** follows:

That said territory, the annexation of which **is** described **as** follows:

A portion of the Northwest and Northeast Quarters of Section 3, Township 3 North, Range 6 East, and the Southeast Quarter of Section 34, Township 4 North, Range 6 East, Mount Diablo Base and Meridian, being more particularly described **as** follows:

Beginning at a point in the North line of said Section 3, said point lying 40.00 feet East of the Northwest corner of the Northeast Quarter of said Section 3, and **being also** the Northwest corner of the **parcel of land** annexed to the City of Lodi **as** the "Rutledge Addition" **and** described in City of Lodi Resolution No. 2875; thence southerly, **along** the West line of said "Rutledge Addition" annexation, being along the existing City Limits line of the City of Lodi, a distance of 630.00 feet; thence leaving said "Rutledge Addition" annexation and City Limits line, North 89° 40' 00" West, parallel with the North line of said Section 3, a distance of 805.00 feet; thence North, parallel with the **East** line of the Northwest Quarter of said Section 3, a distance of 660.00 feet to a point in the North line of TURNER ROAD; thence South 89° 40' 00" East, along said North line, being 30.00 feet North of the North line of said Section 3, a distance of 725.00 feet to intersection with the northerly production of the West line of Lower Sacramento Road; thence South along said northerly production 30.00 feet to the North line of said Section 3; thence South 89° 40' 00" East along said North line, 80.00 feet to the point of beginning, and containing 12.1 acres, more or less.

annexed to the City of Lodi by Council Resolution No. 3629, be and it is hereby declared to be withdrawn from the Woodbridge Rural County Fire Protection District.


