

RESOLUTION NO. 3760

RESOLUTION AMENDING RESOLUTION NO. 3741
PROVIDING FOR CONDEMNATION OF THE HUGHES-
WILSON PARCEL FOR LODI LAKE PARK EXPANSION.

WHEREAS, the City Council of the City of Lodi heretofore adopted Resolution No. 3741 which authorized condemnation proceedings to acquire the Patricia Mason Wilson and Vivian E. Hughes property adjacent to Lodi Lake Park; and

WHEREAS, through an inadvertent mistake the legal description set forth in said resolution was incorrect;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Lodi that the description set forth in Resolution No. 3741 is hereby amended to read as follows:

A portion of Lot 10 and the Southeast Quarter of the Southwest Quarter of fractional Section 35, Township 4 North, Range 6 East, Mount Diablo Base and Meridian and also being a portion of the land described in deed to Lewis T. Mason, recorded September 28, 1929 in Book A of Deeds, Vol. 286, page 107, San Joaquin County Records and more particularly described as follows:

Beginning at the Northwest corner of Lot 190, LAKEWOOD UNIT NO. 4, as filed for record July 26, 1967, in Vol. 18, page 5, Book of Maps and Plats, San Joaquin County Records, said corner being in the South line of the easement granted to the City of Lodi and recorded November 21, 1958 in Book 2118, page 391, Official Records, San Joaquin County, and also being 874.3 feet from the Southeast corner of Lot 16, LAKE HOME SUBDIVISION NO. 2, as filed for record May 29, 1940 in Vol. 11, Book of Maps and Plats, page 56, San Joaquin County Records; thence South $86^{\circ} 12'$ West, along said South line and its extension to a point in the existing Easterly line of the property deeded to the City of Lodi (Lodi Lake Park) by Lewis T. Mason and Clara E. Mason, in deed recorded June 3, 1936 in Book of Official Records, Vol. 531, page 321, San Joaquin County Records; thence Northerly, Northwesterly and Northerly along said Easterly line to its intersection with the South bank of the MOKELUMNE RIVER; thence Easterly and upstream along said South bank to the Northwest corner of the property of LEMOIN F. BECKMAN, said point bearing North $0^{\circ} 13' 00''$ East, from the point of beginning; thence South $0^{\circ} 13' 00''$ West, along the West line of said property to the point of beginning.
