

RESOLUTION NO. 3769

WITHDRAWING CERTAIN PROPERTY ANNEXED TO THE  
CITY OF LODI FROM THE WOODBRIDGE RURAL COUNTY  
FIRE PROTECTION DISTRICT.

WHEREAS, the City Council did by Ordinance No. 996 effective February 21, 1973, approve the annexation of that certain real property, contiguous to the City of Lodi designated as "E. E. Wisner Addition No. 2"; and,

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary of State on March 27, 1973, referring to said Ordinance No. 996, and the annexation of the real property described therein; and

WHEREAS, the affidavit of the City Clerk of the City of Lodi certifying to the annexation of said "E. E. Wisner Addition No. 2" in accordance with law was filed with the County Recorder of San Joaquin County on April 5, 1973; and,

WHEREAS, it is the desire of this City Council that that portion of said property designated as "E. E. Wisner Addition No. 2" which lies within the Woodbridge Rural County Fire Protection District be withdrawn from said District; now, therefore,

BE IT RESOLVED BY the City Council of the City of Lodi as follows:

That that certain real property lying within the said "E. E. Wisner Addition No. 2" and particularly described as follows, to wit:

A portion of the Northeast Quarter of Section 10, Township 3 North, Range 6 East, Mount Diablo Base and Meridian, San Joaquin County, being more particularly described as follows:

Beginning at the Northwest corner of LOT 9 of WISNER TRACT as shown on Map filed for record January 7, 1947 in Volume 11, at page 131, Book of Maps and Plats, San Joaquin County Records said point being also in the East line of HIXSON ADDITION, as annexed to the City of Lodi by Resolution No. 3631, and being on the existing City Limits line of the City of Lodi; thence South 89° 12' 30" East, along the North line of said LOT 9, 104.00 feet; thence South, 80.00 feet to a point in the South line of said LOT 9; thence South 89° 12' 30" East, along the South line of said LOT 9 and the South line of LOT 2 of said WISNER TRACT, 331.10 feet to the Southeast corner of said LOT 2; thence South, along the East line of said WISNER TRACT, 90.50 feet to the Southwest corner of LOT 3 of

TALLEY TRACT as shown on map filed for record August 19, 1953, in Volume 13, at page 162, Book of Maps and Plats, San Joaquin County Records; thence South 89° 12' 30" East, along the South line of said LOT 3, 102.00 feet; thence South, 165.00 feet to a point in the North line of SUN WEST ADDITION, as annexed to the City of Lodi by Resolution No. 3612, and being on the existing City Limits line of the City of Lodi; thence North 89° 12' 30" West, along said City Limits line 102.00 feet; thence North 5.00 feet along the City Limit line; thence North 89° 12' 30" West, along the North line of said SUN WEST ADDITION 435.10 feet to the Southwest corner of LOT 7 of said WISNER TRACT; thence North, along the West line of said WISNER TRACT, 355.50 feet to the point of beginning.

annexed to the City of Lodi by Council Ordinance No. 996, be and it is hereby declared to be withdrawn from the Woodbridge Rural County Fire Protection District.
