

RESOLUTION NO. 3798

WITHDRAWING CERTAIN PROPERTY ANNEXED TO THE
CITY OF LODI FROM THE WOODBRIDGE RURAL COUNTY
FIRE PROTECTION DISTRICT.

WHEREAS, the City Council did by Resolution No. 3773 effective May 23, 1973, approve the annexation of that certain real property, contiguous to the City of Lodi designated as "T. A. Bowen Addition"; and,

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary of State on June 8, 1973, referring to said Resolution No. 3773, and the annexation of the real property described therein; and,

WHEREAS, the affidavit of the City Clerk of the City of Lodi certifying to the annexation of said "T. A. Bowen Addition" in accordance with law was filed with the County Recorder of San Joaquin County on June 14, 1973; and

WHEREAS, it is the desire of this City Council that that portion of said property designated as "T. A. Bowen Addition" which lies within the Woodbridge Rural County Fire Protection District be withdrawn from said District; now, therefore,

BE IT RESOLVED BY the City Council of the City of Lodi as follows:

That said territory, the annexation of which is described as follows:

A portion of the Northeast Quarter of Section 3, Township 3 North, Range 6 East, Mount Diablo Base and Meridian, San Joaquin County, being more particularly described as follows:

Beginning at a point on the City Limits line of the City of Lodi on the East line of Lower Sacramento Road (80 feet wide), said point being the Northwest corner of "TINDELL ADDITION" as annexed to the City of Lodi by City of Lodi Resolution No. 3556; thence leaving said City Limits line, North 0° 36' 30" West; along said East line of Lower Sacramento Road, 605.00 feet, to a point on the City Limits line of said City of Lodi, said point being the Southwest corner of "ERICH ADDITION," as annexed to the City of Lodi by City of Lodi Ordinance No. 746; thence easterly, along said City Limits line, being along the South line of said "ERICH ADDITION," 1070.00 feet to the Southeast corner of Lot 64, ERICH PARK UNIT NO. 1, the map or plat of which was filed for record June 13, 1963

in Book of Maps and Plats, Volume 17, page 20, San Joaquin County Records; thence continuing along said City Limits line, South 0° 36' 30" East, 16.70 feet to the Northwest corner of "MILLS ESTATE ADDITION," as annexed to the City of Lodi by City of Lodi Resolution No. 2970; thence continuing South 0° 36' 30" East along said City Limits line, being along the West line of said "MILLS ESTATE ADDITION," 415.30 feet; thence South 01° 58' 10" East, along said City Limits line, and said West line, 173.09 feet to the Northeast corner of said "TINDELL ADDITION"; thence westerly, along said City Limits line, being along the North line of said "TINDELL ADDITION," 1074.11 feet to the point of beginning, the area thus described, containing 14.87 acres, more or less.

annexed to the City of Lodi by Council Resolution No. 3773, be and it is hereby declared to be withdrawn from the Woodbridge Rural County Fire Protection District.
