

RESOLUTION NO. 412 1

WITHDRAWING CERTAIN PROPERTY ANNEXED TO THE CITY OF LODI FROM THE WOODBRIDGE RURAL COUNTY FIRE PROTECTION DISTRICT.

WHEREAS, the City Council did by Resolution No. 4100 effective October 3, 1975, approve the annexation of that certain real property, contiguous to the City of Lodi designated as "West Turner Road Addition"; and,

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary on October 9, 1975, referring to said Resolution No. 4100, and the annexation of the real property described therein: and,

WHEREAS, the affidavit of the City Clerk of the City of Lodi certifying to the annexation of said "West Turner Road Addition" in accordance with law was filed with the County Recorder of San Joaquin County on October 17, 1975; and,

WHEREAS, it is the desire of this City Council that that portion of said property designated as "West Turner Road Addition" which lies within the Woodbridge Rural County Fire Protection District be withdrawn from said District; now, therefore,

BE IT RESOLVED by the City Council of the City of Lodi as follows:

That that certain real property lying within the said "Woodbridge Rural" County Fire Protection District and particularly described as follows, to wit:

A portion of the Southwest and Southeast Quarters of Section 34, Township 4 North, Range 6 East, Mount Diablo Base and Meridian, being more particularly described as follows:

Beginning at a point in the south line of said Section 34, said point lying 40 feet East of the Southwest corner of said Southeast Quarter, and being the Northwest corner of the parcel of land annexed to the City of Lodi as the "RUTLEDGE ADDITION" and described in City of Lodi Resolution No. 2875; thence East, along the North line of said "RUTLEDGE ADDITION", and its easterly production,

being along the existing City Limit line, 1160.04 feet to the Southwest corner of the parcel of land annexed to the City of Lodi as the "NORTH GENERAL MILLS ADDITION" as described in City of Lodi Ordinance No. 836; thence North 7° 12' East along the West line of said "NORTH GENERAL MILLS ADDITION", 27.22 feet; thence leaving said existing City Limit line, West along a line 27.00 feet northerly of (measured at right angles) the south line of said Southeast Quarter, a distance of 1243.46 feet to a point in the westerly line of said Southeast Quarter of Section 34; thence North 1° 49' West along said westerly line of said Southeast Quarter, a distance of 3.00 feet; thence West 40.00 feet to the intersection of the north line of 60 foot wide Turner Road with the northerly production of the west line of Lower Sacramento Road; thence southerly along said northerly production, 30.00 feet to a point in the South line of said Section 34; thence easterly along said South line of Section 34, a distance of 80.00 feet to the point of beginning, the area described containing 0.8 acre, more or less,

annexed to the City of Lodi by Council Resolution No. 4100, be and it is hereby declared to be withdrawn from the Woodbridge Rural County Fire Protection District.
