

RESOLUTION NO. 4252

WITHDRAWING CERTAIN PROPERTY ANNEXED TO THE CITY OF LODI FROM THE WOODBRIDGE RURAL COUNTY FIRE PROTECTION DISTRICT.

WHEREAS, the City Council did by Resolution No. 4219 effective July 7, 1976, approve the annexation of that certain real property, contiguous to the City of Lodi designated as "Temple Baptist Church Addition"; and,

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary of State on August 12, 1976, referring to said Resolution No. 4219, and the annexation of the real property described therein; and,

WHEREAS, the affidavit of the City Clerk of the City of Lodi certifying to the annexation of said "Temple Baptist Church Addition" in accordance with law was filed with the County Recorder of San Joaquin County on August 24, 1976; and,

WHEREAS, it is the desire of this City Council that that portion of said property designated as "Temple Baptist Church Addition" which lies within the Woodbridge Rural County Fire Protection District be withdrawn from said District; now, therefore,

BE IT RESOLVED by the City Council of the City of Lodi as follows:

That that certain real property lying within the said "Temple Baptist Church Addition" and particularly described as follows, to wit:

A portion of the Northwest and Northeast Quarters of Section 10, Township 3 North, Range 6 East, Mount Diablo Base and Meridian, being more particularly described as follows:

Beginning at the Southwest corner of the parcel of land annexed to the City of Lodi as "HOM ADDITION" and described in City of Lodi Ordinance No. 824; thence

Easterly along the South line of said "HOM ADDITION" 677.5 feet; thence North along said "HOM ADDITION" 200.00 feet; thence Easterly, along said "HOM ADDITION" 312.00 feet to a point lying 40.00 feet East of, as measured perpendicular to, the East line of said Northwest Quarter, said point being also in the West line of that parcel of land annexed to the City of Lodi as "WESTDALE ADDITION" and described in City of Lodi Ordinance No. 719; thence South, parallel to the West line of said Quarter, and along the West line of said "WESTDALE ADDITION" and the West line of that parcel of land annexed to the City of Lodi as "COMMUNITY HOSPITAL ADDITION" and described in City of Lodi Ordinance No. 1047, 1520.65 feet to the Southwest corner of said "COMMUNITY HOSPITAL ADDITION"; thence Westerly, along the South line of the Northeast and Northwest Quarters of said Section 10, 990.5 feet; thence Northerly, along a line lying 1692 feet East of the West line of the Northwest Quarter of Section 10, 1320.7 feet to the point of beginning; containing 31.4 acres, more or less.

annexed to the City of Lodi by Council Resolution No. 4219, be and it is hereby declared to be withdrawn from the Woodbridge Rural County Fire Protection District.
