

RESOLUTION NO. 78-124

AWARD - CONTRACT FOR 15-KV ALUMINUM
XLP CABLE.

WHEREAS, in answer to notice duly published in accordance with law and the order of this City Council, sealed bids were received and publicly opened by the City Clerk of this City on September 12, 1978 at 11:00 a. m. for the contract for 15-KV Aluminum XLP Cable (UD-E78-6); as described in the specifications therefor approved by the City Council August 16, 1978; and


