RESOLUTION NO. 1639

AN ORDER CANCELLING TAXES LEVIED BY THE
CITY OF LODI FOR THE FISCAL YEAR 1951-1952
ON CERTAIN PROPERTY ACQUIRED BY SAN JOAQUIN
LOCAL HEALTH DISTRICT SUBSEQUENT TO THE
LIEN DATE FOR SAID TAXES

WHEREAS, San Joaquin Local Health District is the
owner of the following described property in the City of
Lodi:

- Parcel 1. The South 60 feet of the East one-
half of Lot 6 in Block 11 of Hutchins
Addition to Lodi, except the South
10 feet and except the West 13 feet.
- Parcel 2. The South 60 feet of the West one-
half of Lot 7 in Block 11 of Hutchins
Addition to Lodi, except the South
10 feet thereof.

(Assessed in the name of Theresa Rinn)

WHEREAS, The properties of San Joaquin Local Health
District are exempt from taxation and not subject to tax
sale, and,

WHEREAS, The property above described was acquired
by said San Joaquin Local Health District by deed dated
April 12, 1951, and recorded April 24, 1951, subsequent to
the lien date for City of Lodi taxes for the fiscal year
1951-52, and,

WHEREAS, The County of San Joaquin performs the duties
of assessing and collecting taxes for the City of Lodi and
the tax levied against said property as above described is
displayed on the current assessment rolls of the County of
San Joaquin, therefore,

BE IT RESOLVED AND HEREBY ORDERED That all taxes
levied on behalf of the City of Lodi for the fiscal year
beginning July 1, 1951, and ending June 30, 1952, now a lien
but not due or payable, be and the same are hereby cancelled.

The County Auditor and such other County Officers of the County of San Joaquin as are affected hereby are directed to make entry on the proper records of San Joaquin County to effect the purpose hereof.

RESOLVED, Further, that a certified copy of this resolution be forwarded the Attorneys for San Joaquin Local Health District for presentation to the Board of Supervisors of San Joaquin County.

I hereby consent to the cancellation of City of Lodi taxes on the property described herein.


