RESOLUTION NO. 1847

WITHDRAWING CERTAIN PROPERTY ANNEXED  
TO THE CITY OF LODI FROM THE WOODBRIDGE  
RURAL COUNTY FIRE PROTECTION DISTRICT

WHEREAS, this City Council did by Ordinance No. 505, effective February 20, 1954, approve the annexation of that certain real property, contiguous to the City of Lodi, designated as Century Manor Addition, and

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary of State on February 25, 1954, referring to said Ordinance No. 505, and the annexation of the real property described therein, and

WHEREAS, it is the desire of this City Council that said property designated as Century Manor Addition be withdrawn from the Woodbridge Rural County Fire Protection District, now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LODI AS FOLLOWS:

That that certain real property, designated as Century Manor Addition, and particularly described as follows, to wit:

A portion of the Southwest Quarter of Section 2, Township 3 North, Range 6 East, Mount Diablo Base and Meridian, and more particularly described as follows:


Beginning at the Northeast corner of Lot 14 of the Corinth Tract, as per map filed in Book of Maps, Vol. 13 at Page 39, San Joaquin County Records; thence westerly along the north line of said Lot 14 and its westerly extension, which line is also a boundary line of the City of Lodi, 315 feet, more or less, to the Northwest corner of Lot 13 of said Corinth Tract, which point is also a corner of the present City Limits; thence N 0° 44' W along the west line of Corinth property, as shown on map of survey filed in Book of Surveys, Vol. 8 at Page 41, San Joaquin County Records, 1498.75 feet, more or less, to the north line of the Southwest Quarter of said Section 2, which line is also the present boundary line of the City of Lodi; thence easterly along said north line and City boundary line 488.0 feet, more or less, to the northeast corner of said Corinth property, which point is also a corner of the present City boundary line; thence southerly along the east line of said Corinth property and City boundary line to a point bearing due East from the Northeast corner of Lot 14 of said Corinth Tract,

which point is also • corner of the present City boundary line; thence due west along the present City boundary line to the point of beginning, containing 16.69 acres, more or less.

annexed to the City of Lodi by Council Ordinance No. 505, be and it is hereby declared to be withdrawn from the Woodbridge Rural County Fire Protection District.
