RESOLUTION NO. 1868

WITHDRAWING CERTAIN PROPERTY ANNEXED  
TO THE CITY OF LODI FROM THE WOODBRIDGE  
RURAL COUNTY FIRE PROTECTION DISTRICT

WHEREAS, this City Council did by Ordinance No. 528, effective May 20, 1955, approve the annexation of that certain real property, contiguous to the City of Lodi, designated as Western Addition, and

WHEREAS, there is on file in the office of the City Clerk of the City of Lodi the Certificate of the Secretary of State of the State of California, executed by said Secretary of State on May 23, 1955, referring to said Ordinance No. 528, and the annexation of the real property described therein, and

WHEREAS, it is the desire of this City Council that said property designated as Western Addition be withdrawn from the Woodbridge Rural County Fire Protection District, now therefore,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LODI AS FOLLOWS:

That that certain real property, designated as Western Addition, and particularly described as follows, to wit:

Commencing at a point on the present boundary line of the City of Lodi, which point is also the Northeast corner of the Northwest Quarter of the Northwest Quarter of Section 11, Township 3 North, Range 6 East, Mount Diablo Base and Meridian, and running along the east line of said Quarter Quarter Section to the Southeast corner of said Quarter Quarter Section; thence westerly along the south line of said Quarter Quarter Section to the Southwest corner of said Quarter Quarter Section, which point is on the east line of the Main Canal of the Woodbridge Irrigation District; thence northerly along the west line of said Section 11, which line is also the east line of said Main Canal, a distance of 433 feet, more or less, to the Northeast corner of said Main Canal; thence westerly along the north line of Main Canal 2251.7 feet; thence north 919 feet, more or less, to the north line of the County Road (Sargent Road); thence easterly along the north line of said County Road 3065.4 feet, more or less, to the boundary line of the City of Lodi; thence southerly along said City boundary line 30 feet, more or less, to the north line of said Section 11; thence easterly along said north line and City boundary line to the point of beginning, containing 88.8 acres, more or less.
