RESOLUTION NO. 2019

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LODI
DECLARING THAT PROCEEDINGS HAVE BEEN INITIATED BY
THE CITY COUNCIL TO ANNEX TO SAID CITY CERTAIN
UNINHABITED TERRITORY DESCRIBED HEREIN AND DESIGNATED
"HAM LANE ANNEX", AND GIVING NOTICE OF PUBLIC
HEARING.

WHEREAS, at least three sides of the hereinafter described
territory are contiguous to the City of Lodi, and

WHEREAS, the annexation of the hereinafter described
territory will contribute to the orderly growth of the City,
provide the proper control of street layout, drainage, sanitary
sewer design and proper land use in conformity with the over-
all Master Plan of said City, and

WHEREAS, less than twelve registered voters reside within
said territory, thereby qualifying the territory for annexa-
tion under the provisions of the Annexation of Uninhabited
Territory Act of 1939, and

WHEREAS, the certainty and definiteness of the boundaries
of the proposed annexation were approved by the San Joaquin
County Boundary Commission on April 22, 1954, now therefore,

BE IT RESOLVED, that the City Council of the City of Lodi
does hereby initiate proceedings and declare its intention to
annex to said City, in accordance with the provisions of the
Annexation of Uninhabited Territory Act of 1939, as amended,
that uninhabited territory described as follows:

A portion of the West one-half of Section 2, Town-
ship 3 North, Range 6 East, Mount Diablo Base and Mer-
idian, San Joaquin County, California, and more particu-
larly described as follows:

Commencing at the point of intersection between the South line of the North 10 acres of the East 33 acres of the Southwest Quarter of said Section 2 and the East line of said Southwest Quarter, which point is also a corner of the present boundary line of the City of Lodi, and running northerly along said East line and its northerly extension, said line being also a City boundary line, to its intersection with the center line of West Lockeford Street, which point being also a corner of said City boundary line; thence westerly along said center line and City boundary line a distance of 429.25 feet; thence southerly and parallel to the East line of the Northwest Quarter of said Section 2 to the South line of said Northwest Quarter; thence Westerly along said South line 117 feet, more or less, to the Southeast corner of Lot 39 as said lot is designated on the map entitled, "Gerard Tract," filed August 8, 1916, at page 62, Vol. 8, Book of Maps and Plats, San Joaquin County Records, which point is also a corner of the present City boundary line; thence southerly along the west line of the East 33 acres of the Southwest Quarter of said Section 2, and City boundary line, a distance of 799.83 feet, more or less, to its intersection with the South line of the North 10 acres of the East 33 acres of said Southwest Quarter, which point is also a corner of said City boundary line; thence easterly along said South line and City boundary line a distance of 546.25 feet, more or less, to the point of beginning, containing 14.3 acres, more or less.

BE IT FURTHER RESOLVED, that said territory be designated "Ham Lane Annex" as an appropriate name to be used in reference to said territory further in these proceedings.

BE IT FURTHER RESOLVED, that notice is hereby given that this City Council has fixed Wednesday, the 5th day of June, 1957, at 8:00 p.m. of said day and the City Council Chambers, City Hall, Lodi, California, as the time and place when and where protests of the owners of real property within the boundaries of the territory proposed for annexation will be heard and considered. At any time not later than the hour set for hearing objections to the proposed annexation, any owner of property within the territory proposed to be annexed may file written protest against the proposed annexation. Such protests shall state the name or names of the owner or owners of the property affected thereby and the description and area of such property in general terms.

BE IT FURTHER RESOLVED, that the City Clerk of the City of Lodi be, and he is hereby, directed to cause a copy of this resolution to be published at least twice in the "Lodi News-Sentinel", a newspaper printed, published, and circulated in the City of Lodi, and at least twice in the "Stockton Record", a newspaper printed, published and circulated outside the City of Lodi, all in the time, form and manner required by law.

Certified to be a full, true and correct copy of Resolution No. 2019 of the City Council of the City of Lodi and the same was passed and adopted in regular meeting of said City Council held April 17, 1957.
