RESOLUTION NO. 1139

WHEREAS, Section 1623 of the Streets and Highways Code of the State of California, provides that the Board of Supervisors may expend a portion of the County's Special Road Improvement Fund upon streets, bridges and culverts in incorporated cities within the County, upon such basis and conditions as provided for in said Section 1623, providing the legislative body of said incorporated city or cities shall, by ordinance, or resolution, authorize the County to do and perform, "work of acquisition of real property or interest therein, or rights of way, construction, maintenance, improvement or repair of any street, bridge or culvert within the said incorporated city," and

WHEREAS, Section 3714 of the Political Code of the State of California, as amended in 1941, provides that the Board of Supervisors, upon the filing of a petition or resolution or ordinance by any incorporated city in the County, authorizing the County to do and perform any of the work referred to above, shall set aside at least one day of the period within which a hearing on the annual budget may be had, at which time any authorized officer of said incorporated city within the County, may appear and be heard on matters pertaining to the financing of streets, roads and highways, both within and without the incorporated area of said County; now therefore,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LODI,  
AS FOLLOWS:

That the City of Lodi hereby gives its consent and authorizes the County of San Joaquin, State of California, to do and perform any work of acquisition of real property or interest therein, or rights of way, construction, maintenance, improvement or repair of the projects or the streets, bridges and culverts within the said City of Lodi, hereinafter designated, and request the County of San Joaquin to allocate for, and to expend upon such streets, bridges and culverts within the City of Lodi, such portion of the Special Road Improvement Fund of the County of San Joaquin, during the fiscal year 1942-1943, and upon such basis and condition as the Board of Supervisors of the County of San Joaquin shall provide by ordinance as required by Section 1623 of the Streets and Highways Code of the State of California: be it

FURTHER RESOLVED, that the Board of Supervisors of the County of San Joaquin set aside a day of the period within which hearing on the annual budget may be had, at which time an authorized officer of the City of Lodi may appear and be heard on matters pertaining to the financing of streets, roads and highways within the City of Lodi; be it

FURTHER RESOLVED, that the Board of Supervisors of the County of San Joaquin, adopt the combined factors of streets and highway mileage, and density of traffic, as the basis for distribution and expenditure of a portion of the County's Special Road Improvement Fund, within the City of Lodi, as provided in Section 1623 of the Streets and Highways Code of the State of California; be it


FURTHER RESOLVED, that the following is the project or projects, or streets, bridges and culverts, or other work of improvement within the City of Lodi, or bordering in part or in whole thereon, upon which the City of Lodi requests the County of San Joaquin, to expend a portion of the County's Special Road Improvement Fund, during the year 1942-43, to-wit:

- (a) The drainage of a portion of Turner Road south of Lodi Lake Park.  
Estimated to cost . . . . . \$ 3,500.00
  - (b) The drainage of a portion of Pope Ave., (E. Fine St.) East of Cherokee Lane - Estimated to cost . . . . . 400.00
  - (c) Shoulder work and surfacing of Lodi Ave., (Sargent Road) West from Hutchins St. - Estimated to cost . . . . . 1,800.00
  - (d) Regrading and resurfacing portions of South Church St., South of Chestnut St. - Estimated to cost . . . . . 900.00
  - (e) Continuation of shoulder work on Quimby Avenue from Lodi Ave., to Kettleman Lane - Estimated to cost . . . . . 1,750.00
- The total preliminary estimates of the cost of the above projects being . . . \$ 8,350.00
