

RESOLUTION NO. 1027.

RESOLUTION DECLARING THE INTENTION OF THE CITY COUNCIL
OF THE CITY OF LODI TO ABANDON A CERTAIN TWENTY-FOOT
ALLEY IN BLOCK 2, CENTRAL TRACT.

WHEREAS, Noah Howard has filed a petition requesting the abandonment of that certain alley, dedicated to public use in the official map of "Central Tract" filed January 22, 1924 and recorded in 001.10 of Maps and Plats at Page 78 thereof, San Joaquin County Records, the said alley lying along the southerly line of Block 2 of said Central Tract for a distance of two hundred ninety (290) feet westerly from the west line of South Central Avenue and being ten (10) feet in width.

WHEREAS, the City Planning Commission, after due consideration, offers no objection to the abandonment of this alley, therefore,

BE IT RESOLVED, that it is the intention of this City Council of the City of Lodi that the said alley be abandoned and closed up in that the same is not required to serve a public purpose nor is the same required in the future development of the lands abutting thereon or as a means of ingress or egress therefrom.

The alley herein proposed for abandonment and to be closed up is particularly bounded and described as follows:-

Beginning of the south-east corner of Lot 1 in Block 2 of said Central Tract and running thence Southerly on the west line of South Central Avenue a distance of ten (10) feet, thence Westerly and parallel to the south line of Lots 1, 4, 5, and 6 in said Block 2 a distance of two hundred ninety (290) feet to a point on the west line of Lot 36, Lodi Barnhart Tract, thence Northerly on the said west line of Lot 36 a distance of ten (10) feet to the south-west corner of Lot 6 in Block 2, Central Tract, thence Easterly on and along the south lines of Lots 6, 5, 4 and 1 in Block 2, Central Tract to the south-east corner of Lot 1 in Block 2 of said Tract and the point of beginning.

BE IT FURTHER RESOLVED, that the Street Superintendent of the City of Lodi be, and he is hereby directed, to post and publish notice hereof at the times and in the manner required by law, such publication to be had in "THE LODI TIMES" a newspaper of general circulation, herein designated as the newspaper in which said notice shall be published.
