RESOLUTION NO. 1072

A RESOLUTION AUTHORIZING PETITION TO THE BOARD
OF SUPERVISORS OF SAN JOAQUIN COUNTY, CALIFORNIA
FOR THE CANCELLATION OF CERTAIN TAXES.

RESOLVED By the City Council of the City of Lodi, California, that the City Attorney of said City be, and he is hereby instructed to present the petition of the City Council to the Board of Supervisors of San Joaquin County, State of California, asking that all taxes levied by said County and/or any district in said county, and now remaining unpaid, on the following mentioned properties of said city be cancelled in accordance with Section 4986 of the Revenue and Taxation Code of the State of California, which properties and tax sales thereof are mentioned and described as follows:

San Joaquin County Tax Sale No. 21811 covering Lots 7 and 8 of the BECKMAN TRACT, assessed at the time of the sale in the name of Mrs. T. H. Beckman.

San Joaquin County Tax Sale No. 21513 covering Lot Numbered 19 of the BECKMAN TRACT, assessed at the time of sale in the name of Grace Beckman.

Said real properties are owned by the City of Lodi and are situated in the City of Lodi.

Said petition is annexed hereto and made a part of this resolution as if herein set forth verbatim and in full.

Gentlemen:

City of Lodi, a municipal corporation of the Sixth Class, situate in the County of San Joaquin, State of California, hereby petitions your Honorable Body for an order on the County Tax Collector of this County cancelling all taxes assessed upon the assessment rolls of said County on certain properties in the City of Lodi displayed upon said assessment rolls as follows:

San Joaquin County Tax Sale No. 21811 covering Lots 7 and 8 of the BECKMAN TRACT, assessed at the time of the sale in the name of Mrs. T. H. Beckman.

San Joaquin County Tax Sale No. 21813 covering Lot Numbered 19 of the BECKMAN TRACT, assessed at the time of sale in the name of Grace Beckman.

This application is made pursuant to the provisions of Section 4986 of Revenue and Taxation Code of this state, and petitioner avers that it, the City of Lodi, holds title in fee simple absolute to the land above described, that the same are now and have been since the sixth day of December 1906 included in the corporate limits of the City of Lodi. Petitioner further states that it is a Municipal Corporation of the Sixth Class and is the owner of said parcels of real property and that none of said real property is lawfully subject to tax sale.
