

WHEREAS Lewis T. Mason, also called L. T. Mason, and Clara E. Mason, his wife, have made and executed and tendered to the City of Lodi, a Municipal Corporation, a deed conveying to the said city a parcel of land situated in the County of San Joaquin, State of California, and described as follows, to-wit:

The South half ( $S\frac{1}{2}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of the Southwest Quarter ( $SW\frac{1}{4}$ ) of Section Thirty-five (35) in Township Four (4) North, Range Six (6) East, Mount Diablo Base and Meridian, and also all that portion of the South half ( $s\frac{1}{2}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of the Southeast Quarter ( $SE\frac{1}{4}$ ) of Section Thirty-four (34), in the same Township and Range, lying Easterly of a line running parallel with and Thirty-two (32) feet Easterly (measured in a horizontal line) from the center line of the levee now existing and standing on the lands of Estella M. Smith, which levee runs in a general Northerly and Southerly direction and is approximately 150 feet Westerly from the Section line running North and South between said Sections 35 and 34, and being Twenty-three (23) acres of land, more or less.

Also that portion of Lot 54 Gerard Tract, lying North of a line running parallel with and Fifteen (15) feet Northerly (measured in a horizontal line) from the center line of the levee now existing and standing thereon; and a small triangular piece joining on the West, following the contour on the Northerly and North-easterly side of levee roadway as now constructed to a point on the Southern boundary of Section 34, 32 feet easterly from the center line of said levee; thence Easterly to the Section corner; thence Southerly to the point of commencing, Said lot is delineated and so designated upon that certain Map entitled "Map of the Gerard Tract" filed for record August 8th, 1916 at 4:44 P.M. in the office of the County Recorder of the County of San Joaquin, State of California.

NOW THEREFORE, BE IT RESOLVED, By the City Council of said City of Lodi that said deed and transfer shall be and the same is hereby accepted and approved and that the said deed shall be recorded in the office of the County Recorder of the County of San Joaquin, State of California, and that a certified copy of this resolution be annexed to the said deed prior to its recordation.


