RESOLUTION NO. 952

RESOLUTION ESTABLISHING ELECTION PRECINCTS, DESIGNATING THE POLLING PLACES THEREOF AND APPOINTING ELECTION OFFICERS AND FIXING THEIR COMPENSATION FOR THE GENERAL MUNICIPAL ELECTION TO BE HELD TUESDAY, APRIL 12, 1938.

WHEREAS, in accordance with Section 852 of the Municipal Corporations Act as amended by Stats. 1937, Chapter 659, a general municipal election is to be held and conducted in the City of Lodi on Tuesday, the 12th day of April, 1938, for the purpose of electing three (3) City Councilmen each for a full term of four (4) years;
