

RESOLUTION NO. 2013-128

A RESOLUTION OF THE LODI CITY COUNCIL REJECTING
ALL BIDS AND AUTHORIZING RE-ADVERTISEMENT FOR
BIDS FOR THE PURCHASE OF UNDERGROUND CABLE

WHEREAS, the 1100kCMIL 15kV and 750kCMIL 15kV underground cables are a standard component of the City of Lodi Electric Utility inventory for trunk feeder and substation getaway portions of the underground distribution system; and

WHEREAS, the current inventory level is under the minimum level with the last procurement for this cable made on November 2011; and

WHEREAS, in order to fill the minimum stock level, staff recommends purchasing the 7,500 feet of 1100kCMIL, AWG 15kV underground cable and 12,000 feet of 750kCMIL, AWG 15kV underground cable; and

WHEREAS, on July 3, 2013, the following bids were publicly opened:

WHEREAS, the bid from General Cable exceeds the quantities in the City's bid specification, and the bid from Prysmian Cables exceeds the quantity for one of the cables, therefore each is considered non-responsive; and

WHEREAS, the Okonite bid is responsive however the per-unit pricing is substantially higher than the other two responses; and

WHEREAS, staff recommends rejecting all bids and authorizing re-advertisement for bids with a quantity range rather than a set amount; and

WHEREAS, the estimated cost is \$150,000, and funding is available and included in FY2013/14 Budget Account No. 160.1496.

NOW, THEREFORE, BE IT RESOLVED that the Lodi City Council does hereby reject all bids and authorize re-advertisement for bids for the purchase of underground cable.
